After reviewing the data presented, the team agreed to first review deaths of youths by [opioid poisoning](#). According to the data, this was a large number over the period of 2015-2019 in youth aged 15-21. A second death type will be picked later in the year but suggestions were motor vehicle accident deaths and death by firearms. Another suggestion for future reviews would be to pick an age group instead of a type to focus on.
