  - o 2<sup>nd</sup> year fellow at Lamprey Health Care
    - Background is psych nursing
  - All new graduates would benefit from fellowship
    - At the time of graduation, nurses can practice safely but there are areas not taught in school like time management, day-to-day, and other practice considerations
    - The fellowship helped tremendously for success
      - Felt very welcome, extra support helped ease anxiety and ensured retention
  - o There are a large number of new graduates that don't stay in health care
    - 2 preceptors left clinical work entirely because they felt unprepared and overwhelmed
  - Newer opportunities
    - Works in Nashua soup kitchen and shelter to provide health care
      - Current pandemic prevents operation to function at capacity
        - o But people they see are happy to have them there

Many don't feel comfortable going to a traditional health care setting

## WHATIS A PSYCHOLOGIST?

AND WHAT DO THEY DO?

From the American Psychological Association (APA): "Psychologists have a doctoral degree in psychology from an organized, sequential program in a regionally accredited university or professional school."

States ultimately determine the licensure requirements of a psychologist granted privileges in that jurisdiction. These typically include:

- Completion of the doctoral degree from an APA or regionally accredited university
- Completion of a one-year clinical internship
- Completion of a one-year fellowship occurring after completion of the terminal degree

## WHATIS A PSYCHOLOGIST?

AND WHAT DO THEY DO?

### Practicing psychologists (clinical, counseling, school) provide:

- Diagnostic assessment
- Psychological testing & evaluation

### Transition to Retention

Nationally, 35% of interns complete fellowship <75 miles from internship

### **FELLOWSHIP**

53% of practicing psychologists take a position <75 miles from their fellowship

In the past five years, 50% (n=4) of D-H fellows transition to positions <75 miles for site



## INDEPENDENT PRACTICE

Overall, 41% of psychologists remain in the state where they trained for at least the first position after fellowship

In the past five years, 18% (n=3) of our interns remain in NH serving the community

Grant-funded pilot project to demonstrate feasibility and financial model for intern training in primary care


One day per week in CHaD Pediatric Primary Care, supervised by psychologist and embedded social worker

### Outcomes:

- Valued by the primary care workforce and patients
- Mix of ongoing care and brief consultations
- Need to improve use of the integrated behavioral health model
- Partial reimbursement (payment problems), but offset by value to clinic
