The Child Fatality Review Committee was given a presentation on fire safety and education that is being performed across the state of New Hampshire. There are many programs that go out into the community and to schools to help educate the public on fire safety. The top two causes of fires in New Hampshire are cooking and heating.

An interesting part of the data is that building fires have decreased 57% over the last 10 years, but the total minutes you safely have to get out of the house has gone from around 17 minutes to 2-3 minutes before a majority of the structures are fully engulfed. Follow the rule: Get Out, Stay Out.
