Discussion on chair and alternate chair.

Annual report approved.

### TC101 Slide Deck

Discussion on formatting and references, and one edit to the Cannabis Use Disorder slide (reverse order of therapeutic cannabis and recreational use information).

Discussion on new "anecdotal" slides.

- Brown presented additional slides based on information collected from the ATCs regarding effectiveness of products relative to certain qualifying conditions
- Board agreed that anecdotal information was important to include in this slide deck
- There was a suggestion of a separate slide deck focused on the "patient experience."

- Board agreed that the slides presented, in order to be included in the current TC101 slide deck, should be fewer and should not include testimonials, and a diagnosis-bydiagnosis listing was not the bet approach.
- Holt argued that the slide deck, without this anecdotal effectiveness information was overwhelmingly cautionary.
- Withrow offered that providers who reach out to her, as they consider certifying patients for the cannabis program, want to know how cannabis works, in practice, on patients.
- Holt offered to work with Brown to consolidate the slides so that they could be included in this TC101 slide deck at a later time.
- TC101 slide deck, minus the anecdotal effectiveness slides, approved and approved to be posted to TCMOB webpage.

### Legislative Update

Discussion on HB1598, relative to legalizing the possession and use of cannabis

- Matt Simon, Legislative Director for Prime ATC, expressed concern about the bill relative to the viability of the Alternative Treatment Centers and by extension the Therapeutic Cannabis Program
- Board agreed to take a neutral position on the bill, but agreed to provide a statement in support of the Therapeutic Cannabis Program relative to any legalization efforts
- Board approved the following language:
  - Any legislation that would legalize adult-use cannabis in New Hampshire should be evaluated in light of its potential impacts on the Therapeutic Cannabis Program. The TCP is valuable and must be preserved if adult-use legalization passes.
