Dear Provider:

This letter provides updated information on the 2016 - 2017 Modified Stage 2 and Stage 3 Public Health Meaningful Use Objectives as related to the CMS Medicare and Medicaid Electronic Health Record (EHR) Incentive Programs in New Hampshire.

CMS released a <u>final rule</u> that specifies criteria that eligible professionals (EPs), eligible hospitals (EHs), and critical access hospitals (CAHs) must meet in order to participate in the Medicare and Medicaid Electronic Health Record (EHR) Incentive Programs. The final rule's provisions encompass 2015 through 2017 (Modified Stage 2) as well as Stage 3. Both of these programs require that Eligible Professionals (EPs) and Eligible Hospitals (EHs) report on Public Health Meaningful Use Objectives, as applicable, when attesting as a meaningful user of Certified EHR Technology (CEHRT).

Regarding New Hampshire's readiness for Public Health Meaningful Use Objectives for Program Year 2017, the New Hampshire Department of Health and Human Services (NH DHHS) continues its readiness for the Modified Stage 2 Syndromic Surveillance measure and the Electronic Laboratory Reporting (ELR) measure for EHs using 2014 certified technology and Cancer Registry Reporting for EPs using 2014 certified technology following implementation guides as referenced in the *Updated Meaningful Use Quick Reference Guide 2016 – 2017 dated February 2017*. Note: For the purposes of the Medicaid EHR Incentive Program, the federal statute authorizes eligible professionals attesting to Modified Stage 2 MU in 2017 to submit data to the cancer registry via CEHRT or other electronic means, further described in the *Updated Meaningful Use Quick Reference Guide 2016 – 2016 – 2017 dated February 2017*.

NH DPHS declared readiness in June 2016 for Public Health Meaningful Use Objectives for Program Year 2017 optional Stage 3 Measure 6 Electronic Laboratory Reporting for EHs using 2015 certified technology and following the implementation guide as referenced in the *Updated Meaningful Use Quick Reference Guide* 2016–2017 dated February 2017.

Please note that there may be a need to revalidate data submissions whenever a CAH, EH or EP updates or purchases new certified software.
