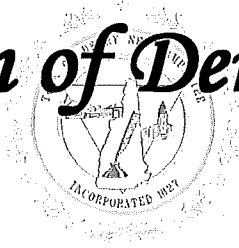

RE: 1<sup>st</sup> Opioid Litigation Settlement Fund Distribution

Deputy Attorney General Boffetti,

The Town of Derry received the 1<sup>st</sup> Opioid litigation settlement in the amount of \$6,961.23 in June 2021 from the State of New Hampshire. Upon receipt of these funds, the Town's governing body established a separate expendable trust fund to assist with accounting, investment and distribution of all proceeds received from settlements and judgements.

To date, none of these funds have been spent on Opioid mitigation as outlined in RSA-A:86. As the amount of available resources has become clearer, we will be developing a mediation plan with the Town's impacted departments and health partners in the near future.

We will forward an updated progress report by the due date of September 1, 2022.

Deputy Attorney General Boffetti,

The Town of Derry received the 2nd Opioid litigation settlement in the amount of \$19,252.30 in June 2022 from the State of New Hampshire. In 2021, the Town's governing body established a separate expendable trust fund to assist with accounting, investment and distribution of all proceeds received from settlements and judgements related to this litigation. The June receipt was placed in this fund in August 2022.

To date, none of these funds have been spent on Opioid mitigation as outlined in RSA-A:86. We continue to develop a mediation plan with the Town's impacted departments and health partners and hope to have that plan finalized soon.

Unless otherwise instructed, we will continue to file updated progress reports with your office.

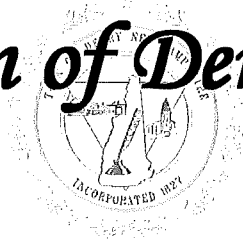

RE: 3<sup>rd</sup> Opioid Litigation Settlement Fund Distribution report

Deputy Attorney General Boffetti,

Since our last report dated 9/1/22 was filed, the Town of Derry has received an additional \$141,074.13 in Opioid Litigation Settlement Fund distributions. To date, the total of funds received is \$167,284.66. All funds received have been placed in the Town's separate expendable trust fund which as of 6/30/23, had a balance of \$168,190.17, interest earnings included.

To date, none of these funds have been spent on Opioid mitigation as outlined in RSA-A:86. We continue to develop a mediation plan with the Town's impacted departments and health partners. As soon as we can determine the amount of future funds that will become available, the plan can be finalized.
