In concert with the above consideration, CLM was recently invited by Catholic Medical Center (CMC) to participate in the dialogue that is evolving resulting in the inclusion of Derry in its Letter of Intent. Included in the dialogue in Manchester is the recognition that a partnered approach be considered as part of the process moving forward. The Center for Life Management has had a long standing commitment to collaboration over the course of nearly fifty (50) years and intends to work very closely with CMC and all of the Manchester providers throughout this process.

Finally, as the designated community mental health center for Region 10, CLM is the largest behavioral health provider of services to Medicaid enrollees in our region. This includes its 24/7 hour contract with Parkland Medical Center. Also, it has close working partnership with Pinkerton Academy, including a contract to provide behavioral health consultation on-site at the school.
