Time allotted | 45 minutes | Agenda topic: Suicide Prevention in NH | Presenter Jennifer Sabin

- Jennifer Sabin is the new Suicide Prevention Coordinator. The need for this position was driven by the 10 Year Mental Health Plan. Jennifer works with many different agencies across state agencies and stakeholders around the state. Jennifer helps lead the state's Suicide Prevention Council. This council meets every other month.
- NH now is working on getting out the word about the new 988 number for a crisis line that goes live in July. NH also has their own line that can be used by anyone in the state, even visitors. That number is 833-710-6477.
- Mental Health Centers in NH has Crisis Teams that can be sent out to the person in crisis directly. These teams usually comprise of a clinician and a peer support person. In some areas this isn't always doable. So then telehealth is usually used. The crisis line personnel also has the ability to make next business day appointments for those where that option is the right one.
- VA in Manchester is taking on the zero suicide model. They are the first VA in the nation to do so.
- Jennifer is working with the Department of Safety to help screen 911 calls for mental health.
- Jennifer is looking forward to helping the Child Fatality Review Committee coordinate recommendations and work together in the future.
