ADDENDUM #2

On March 6, 2018, the New Hampshire Department of Health and Human Services published a request for proposals, requesting proposals from qualified vendors to enter into a lease agreement to occupy space that is currently unoccupied at the Sununu Youth Services Center located at 1056 River Road, in Manchester, NH in order to operationalize a 36-bed residential substance use disorder treatment center for adolescents ages twelve (12) to eighteen (18) years.

The Department is publishing this addendum to correct referencing, as well as to **reschedule the Site Visit:**

- 1. Delete and replace the last paragraph in Section 1 Introduction, Subsection 1.2 Purpose and Overview with the following:**

The Department recognizes that the selected vendor may choose to use subcontractors with greater expertise to perform certain services and/or functions for efficiency or convenience. (See Section 6.10 and Section 7.2.2.8 for detailed requirements should the selected vendor use subcontractors).
