Medicaid Care Management Step 2:

Notice is hereby given that the New Hampshire Department of Health and Human Services is presenting the Medicaid Care Management Step 2 Final Draft Design Considerations. This presentation will describe how New Hampshire will provide Choices for Independence Waiver services through contracted Managed Care Organizations (MCOs), and how New Hampshire will implement mandating enrollment into the Medicaid Care Management program for all non-exempt Medicaid recipients.

This notice and presentation is the next stage in providing opportunity for meaningful public input regarding the provisions of Choices for Independence Waiver services through contracted Managed Care Organizations and mandating enrollment into the Medicaid Care Management program for all non-exempt Medicaid recipients.
