New Hampshire Incorporates Education to Enhance Case Reviews and Prevention

New Hampshire's Child Fatality Review Committee (CFRC), housed in the Division of Public Health Services, operates at the state level. Their team includes medical, law enforcement, judicial, education, and legal representatives, as well as team members from public health, mental health services, and child protection. There are times when a local agency staff member familiar with a child death will attend the case review to provide additional information. Commonly, the CFRC will open with an educational component for the team that includes information that can support them in more effective fatality reviews or enhanced prevention recommendations.

In their recent meeting in January where they reviewed fire related deaths, the first half hour of the CFRC meeting was conducted as a public session prior to moving into non-public session for child death reviews. The public session consisted of a half hour education opportunity from the state Fire Marshal's Office's Public Education Team. They gave a presentation on fire risk, fire safety and public safety messaging, and highlighted educational efforts and content being performed across the state of New Hampshire. This provided the CFRC with an understanding of what programs are currently being offered in communities and schools and how the public is currently educated about fire safety. They then conducted the reviews in non-public session using the National Center's guidance on effective reviews of fire and burns.

Providing educational opportunities to fatality review teams, especially from key public health and public safety partners, is a strategy to ensure more thorough case reviews and more effective recommendations. It is also a way to ensure that the team is abreast of the most recent developments in a quickly-changing landscape. Fatality review teams may consider reaching out to member or ad hoc member partners to identify what information would be most valuable to teams conducting reviews and crafting recommendations.
