Meeting Discussion:

The group engaged in brief introductions as Juvenile Probation Parole Officer Jasmine Gerow-Garthright joined the team. She advised of her experience collaborating with the Nashua community NAACP meetings with law enforcement.

The group engaged in meaningful discussions around the purpose of its upcoming juvenile justice DEI networking forum and panel discussions. Reviewing the purpose of the event, which is to bring together local NH DEI/R-ED teams on a quarterly basis with the goals of collaborating the work that is occurring around the state. The purpose of the panel presentations is to kick off the meetings by harnessing the attendee's empathy so that they are empowered to by this important work. The group planned around supporting both panelists and attendees during conversations that can be emotional and critical. The facilitators will meet with panelists via zoom for preparation prior to the event. SRO Bergeron discussed the importance of a balanced panel. The team discussed the capabilities of the youth and parents who have been connected for the panel thus far.
