Re: Annual Report for System of Care for Health Aging

BACKGROUND

In accordance with the requirements of <u>State House Bill 2, Chapter 79:568</u> of 2023, the Department of Health and Human Services (Department) is providing its first annual report to the Governor, the Joint Legislative Oversight Committee on Health and Human Services, and the New Hampshire State Commission on Aging:

151-E: 27, IV: Beginning November 1, 2023, and annually thereafter, the department shall report to the governor, the state commission on aging established in RSA 19-P:1 and the joint legislative committee on health and human services established in RSA 126-A: 13. The report shall provide detailed information regarding the status of the implementation of this subdivision.

In June of 2023, included as part of the approved biennium budget for SFY24 and SFY25, is an investment in a System of Care for Healthy Aging. This investment provides the required and necessary resources to create and expand capacity, take steps to expedite and improve access to Home and Community Based Services, provide adequate infrastructure funding for staffing, oversight, and information technology, and to use data to inform system and service delivery, including future investments. The system of care aims to establish and implement a comprehensive and coordinated system of care that promotes healthy aging and enables older adults and adults with disabilities to have a meaningful choice in care options, including the ability to receive the care they need in their homes and communities. The system of care shall have the following characteristics:

- 1) A comprehensive array of long-term services and supports including, but not limited to, personal care, homemaker services, transportation, meal delivery or preparation, emergency response systems, adult day care, and family caregiver support to enable older adults and adults with disabilities to remain independent and in the setting of their choice.
- 2) An absence of significant gaps in services and barriers to services.
- 3) Sufficient administrative capacity to ensure quality service delivery.
- 4) Services that are consumer-driven, community-based, and culturally and linguistically competent.
- 5) Transparent, with information made available and known to consumers, providers, and payers.
- 6) A funding system that supports a full range of service options.
- 7) A performance measurement system for accountability, monitoring and reporting of system quality, access and cost.

To support the work to develop the System of Care for Healthy Aging, the Department has formed a cross department team to lead the work to implement the system of care. The Bureau of Elderly and Adult Services (BEAS) continues to work with federal, state, and local agencies, service providers, the private, volunteer, and business sectors, and constituent groups to collectively plan and coordinate a person-centered system of care. BEAS has held meetings to inform and engage stakeholders and internal Department teams as part of our work to develop this initial plan. The Department presented the initial plan development and updates at:

- The Long Term Care Policy Summit on August 21, 2023;
- Alliance for Healthy Aging Advocacy Sub-Committee Meetings held in August 7, 2023 and September 11, 2023; and
- The Home Care Alliance Membership meeting on October 13, 2023.

A critical component to the System of Care is enhancing and expanding the role and functions of New Hampshire's network of Aging and Disability Resource Centers (ADRC) will be expanded and enhanced through this work to include, but not be limited to:

- Expanding capacity to include person-centered counseling services,
- Establishing performance measures for each ADRC office.

As outlined below, the Department will begin to increase this capacity by providing additional resources for increased staffing within the ADRCs. The Department will also be resoliciting the contracts with increased expectations towards the development of a System of Care for Healthy Aging.

Below are status updates of current work the Department has engaged in towards the goals outlined in HB2.
