### Electronic Infectious Disease Surveillance System

On March 2, 2022, the New Hampshire Department of Health and Human Services published a Request for Proposals (RFP), seeking a vendor to develop and maintain a new electronic infectious disease surveillance system (with associated user interface) to modernize disease reporting, surveillance and management.

The infectious disease surveillance system is critical to the State’s capacity to monitor and control the spread of infectious diseases, detect outbreaks of infectious diseases, to respond in a timely manner to control their spread, and to report data to the Centers for Disease Control and Prevention as required.
