

## **ADDENDUM #4**

BEAS Nutrition Services

On March 1, 2022, the Department published a Request for Applications (RFA) to solicit applications for the provision of one (1) or more of the following services to support the older adult and disability populations throughout New Hampshire:

- 1. Home-delivered meals; and/or
- 2. Congregate meal services to support adults who reside in New Hampshire.

The Department is publishing this addendum to:

- 1. Delete and replace Section 1, Request for Services, Subsection 1.1, Purpose and Overview, Paragraph 1.1.1, Line 2, with the following:
  - 2. Congregate meal services to support adults as described in 1.1.2.
- 2. Delete and replace Section 1, Request for Services Subsection, 1.2, Scope of Services Paragraph, 1.2.3., Subparagraph 1.2.3.2, Part 1.2.3.2.1.with the following:
  - 1.2.3.2.1. In the event of a State of Emergency declaration from the federal or state Government, the Vendor shall collaborate with The Department to develop a plan to provide support services to eligible clients who may be homebound in accordance with the OAA during said declaration.
- 3. Delete and replace Section 1, Request for Services Subsection, 1.2, Scope of Services, Paragraph, 1.2.8, Client Donations and Fees, Subparagraph 1.2.8.1, Part 1.2.8.1.6 with the following:
  - 1.2.8.1.6 Agrees to report the total amount of donations collected from individuals to the Department on a *quarterly* basis.
- 4. Delete and replace Section 1, Request for Services Subsection, 1.2, Scope of Services, Paragraph, 1.2.14, Client Feedback, Subparagraph 1.2.14.1 with the following:
  - 1.2.14.1 The selected Vendor must obtain client feedback as required in New Hampshire Administrative Rules <u>He-E 501.13</u> using a method approved by the Department within thirty (30) days of the contract effective date.
