

# ADDENDUM #1

## RFP# RFB-2024-HH-02-EXTER Exterior Oil Tank Painting and Repair Services

(Changes are in <u>bold, underlined and italicized text</u> below to enable vendors to quickly recognize changes in paragraphs and/or wording.)

On June 14, 2023, the New Hampshire Department of Health and Human Services published a Request for Bids, soliciting bids to provide exterior coating and repair services for one (1) 6,000 gallon capacity outside oil tank measuring eight (8) feet in diameter by sixteen (16) feet in length, and for one (1) attached steel secondary containment unit measuring ten (10) feet, nine (9) inches in width, twenty (20) feet nine (9) inches in length, and four (4) feet, two (2) inches in height, with a steel pitched containment cover, and support legs, located on the grounds of Hampstead Hospital and Residential Treatment Facility (HHRTF) at 218 East Road in Hampstead, New Hampshire.

The Department is publishing this addendum to:

# 1. Delete and replace Section 2, Statement of Work, Subsection 2.1, Scope of Services, Paragraph 2.1.6, with the following:

- 2.1.6. The selected Bidder must provide all labor, materials, and equipment necessary to complete the services, which include, but are not limited to:
  - 2.1.6.1. Scheduling all visits to the worksite at dates and times approved by the Department.
  - 2.1.6.2. Ensuring the purposes of the scheduled visits include, but are not limited to:
    - 2.1.6.2.1. Inspections and preparation of the storage tank and secondary containment unit
    - 2.1.6.2.2. Deliveries.
    - 2.1.6.2.3. Cleaning and maintenance.
    - 2.1.6.2.4. Removal of materials, tools, and equipment.
  - 2.1.6.3. Removing all loose rust and scale with wire brushes, hand scrapers, <u>and/or sandblasting</u>, in accordance with The Society for Protective Coatings Surface Preparation Specification #2 (SSPC-SP 2), as approved by the Department.

#### 2.1.6.4. <u>Removing all adhesive decals from the exterior of the</u> <u>tank and secondary containment unit.</u>

2.1.6.5. Priming the exterior of the tank and secondary containment unit and applying one coat of DTM (direct to metal) exterior



paint that is resistant to oil, <u>to be approved by the</u> <u>Department.</u>

- 2.1.6.6. Priming the interior of the secondary containment unit, including the part of the tank that is inside the secondary containment unit, but excluding the inside of the pitched cover, with a paint that is resistant to immersion in oil, and applying one coat of DTM exterior paint that is resistant to immersion in oil, to be approved by the Department.
- 2.1.6.7. <u>Reattaching new adhesive decals to the tank and</u> <u>secondary unit, to be provided by the Department.</u>
- 2.1.6.8 Cleaning the worksite and removing debris from the premises.
- 2. Delete and replace Section 3, Bid Evaluation, Subsection 3.1, Bid Scoring, Paragraph 3.1.1, with the following:
  - 3.1.1. Bid scores will be calculated based on the Total Cost Bid as submitted on Appendix B <u>Addendum #1</u>, Transmittal Letter, Bidder Information and Bid Sheet, Table B-1, Bidder's Cost Bid, Line<u>4</u>, Total Cost Bid.
- 3. Delete and replace Section 3, Bid Evaluation, Subsection 3.2, Bidder Selection, Paragraph 3.2.2, with the following:
  - 3.2.2. One (1) Bidder with the lowest Total Cost Bid as submitted on Appendix B <u>Addendum #1</u>, Transmittal Letter, Bidder Information and Bid Sheet, Table B-1, Bidder's Cost Bid, Line <u>4</u>, Total Cost Bid will be selected.
- 4. Delete and replace Appendix B, Transmittal Letter, Bidder Information, and Bid Sheet, and replace it in its entirety with Appendix B Addendum #1, Transmittal Letter, Bidder Information, and Bid Sheet, which is attached hereto and incorporated by reference herein.
